There are 40 openings and 10 waitlist positions for Certified BBQ Judges at each of the local and regional events. Your Contest Rep will seat you as a judge or assign your duties as a table captain or volunteer. As always, all judges will be considered volunteers and have to take the KCBS pledge prior to being seated.
