ADDITIONAL INFORMATION (updated 5/25/21)

- VFW Table Captain class fee to KCBS is \$25.00 for each student. Please note this rate is only available for classes held at VFW.
- The VFW CBJ class fee to KCBS is \$25.00 for each student. This covers cost for instructor, assistant and CBJ class materials (i.e. manual, CBJ badge, plates, judging slips, comment cards, CBJ pin and CBJ lanyard). Please note this rate is only available for classes held at VFW.
- The VFW Class Organizer will set the fee above the \$25.00 to cover their extra costs (i.e. meat, cook, facility, supplies).
 The Instructor or KCBS office can help the Organizer in setting the class fee, if needed.
- The VFW Class Organizers are responsible for securing meat, cook and class cooking supplies (i.e. water, crackers, clamshells, gloves, forks, paper towels). We recommend reaching out to local vendors for donations.
- The VFW Class Organizers are responsible for travel expenses for instructors.
- Minimum CBJ class size is 24 students when a class is NOT held in conjunction with the contest dates. If you proceed
 with a class with fewer than 24 students, you will still be charged for 24 students.
- Minimum CBJ class size is 18 students when the class is held in conjunction with any KCBS sanctioned contest.
- If the 24 or 18 minimum students are not meet for a CBJ Class, the Organizer will make up the shortage of students by paying \$25.00 per student.
- Minimum of 10 students are needed for a Table Captain Class, the Organizer will make up the shortage of students by paying \$25.00 per student.
- Any approved media or previously Certified Barbeque Judge may attend the class at no charge and cannot be counted toward the 24 or 18 minimum student counts. The previously Certified Barbeque Judge and/or Table Captain will review the Power Point but will not taste the meats.
- The VFW Class Organizer will provide a class roster, at least one week prior to the class, to the KCBS office. This will
 ensure all students are in fact KCBS members in good standing. Following the class, the organizer will provide to the
 KCBS office a final attendee list. KCBS office will provide you with the Google Sheet to be used.
- The VFW Class Organizer to provide necessary media equipment (i.e. projector, microphone, screen) for use by the Instructor for presentation purposes.
