



3rd Annual York County BBQ Festival BBQ Competition June 28th and 29th, 2019 Yorkcountybbqfestival.com

Welcome to the York County BBQ Festival presented by Exelon Generation. This year's event, benefits Tourism and Community Involvement to York County and specifically the Delta Borough Community. This Challenge is proclaimed by our governor as a State Championship and Kansas City Barbeque Society (KCBS) sanctioned competition in the State of Pennsylvania. As a state championship event, the champion will receive an invitation to the Jack Daniel's World Championship cook-off.

The competition will be held at Delta-Peach Bottom Recreation Center located at 5 Pendyrus Street in Delta, Pennsylvania. The York County BBQ Festival will be a two-day competition and Festival beginning Friday (5P-10P) & Saturday (11A-10P).

Barbecue Competitions

We are offering multiple competitions this year. The KCBS Professional, the Backyard Barbecue, Kids Que, Captain of the Sauces, and SCA competitions.

KCBS Master Series.

This is the most popular type of contest KCBS sanctions. A Master Series requires teams to cook 4 meats (Chicken, Pork Ribs, Pork Butt, & Brisket). The cooking source at a Master Series shall be of wood, wood pellets or charcoal. KCBS Rules and regulations apply. Master Series are eligible for American Royal and Jack Daniels World Championship, upon meeting qualifying criteria. In addition, all teams who participate in a Master Series earn points towards KCBS Team of the Year awards presented at our annual banquet. The KCBS Rules and regulations can be found on their web-site: www.kcbs.us. The Four KCBS Meat Categories:

CHICKEN: Chicken includes Cornish Game Hen and Kosher Chicken.

PORK RIBS: Ribs shall include the bone. Country style ribs are prohibited.

PORK: Pork is defined as Boston Butt, Boston Roast, Picnic and/or Whole Shoulder, weighing a minimum of four (4) pounds at the time of inspection. After trimming, pork shall be

cooked whole (bone in or bone out), however, once cooked, it may be separated and returned to the cooker at the cook's discretion. It may be turned in chopped, pulled, chunked, sliced or a combination of any of those.

BEEF BRISKET: May be whole brisket, flat, or point. Corned beef is not allowed. Food turn in and awards for Master Series will be on Saturday.

KCBS Backyard Barbecue.

The Backyard Series is intended to promote barbecue in small towns across the country. They are to be comprised of non-professional teams that are required to cook chicken and pork ribs to win the Grand Championship. Teams who have not competed in more than 12 Master Series competitions in the past year or individuals who have not competed in more than 3 Master Series competitions in the past year can register for this competition.

The cooking source at a Stand Alone Backyard Contest shall be of wood, wood pellets or charcoal. KCBS Backyard Rules and regulations apply. Teams that are registered with KCBS will receive TOY (Team of the Year) points. The KCBS Rules and regulations can be found on their web-site: www.kcbs.us.

The Two KCBS Meat Categories will be:

CHICKEN: Chicken includes Cornish Game Hen and Kosher Chicken.



PORK RIBS: Ribs shall include the bone. Country style ribs are prohibited. Food turn in and awards for Master Series will be on Saturday.

Kids Que.

The **Kids Q** competition is an opportunity for kids to take center stage in their very own grilling competition! Are you or anyone you know from 4 to 16 years of age, someone who loves to cook, and would like a chance to win at a real BBQ competition? Then why not enter the Kids Q Competition.

The two meat categories will be:

CHICKEN: Any Chicken includes legs, thighs, wings or breasts.

BEEF: Any Beef includes steaks, burgers or chopped steak.

Kids Q Category Rules

- Prep, cooking and presentation must be done by the kids
- There must be 6 samples turned in
- Boxes will be provided for turn-in, or you can use your own presentation platter
- No garnish required
- Any outdoor cooking method will be permitted...gas grill, charcoal, propane, etc.
- A parent must be present to assist with any open flames, knives and food handling/sanitation.



Competitors will be judged based on Flavor, tenderness, appearance, and creativity. The judges will taste the finished product and award gift certificates to 1st, 2nd, and 3rd place winners.

SCA Steak Competition.

The SCA Steak competition is sanctioned by the Steak Cookoff

Association, and will be judged according to SCA rules and standards. More information about the SCA rules can be found on their web-site: www.steakcookoffs.com.

All SCA events are required to maintain the same standard of a 1 1/8" Boneless Choice Ribeye. The steaks are provided by the event promoter, leveling the competitive playing field. This event will be held in its entirety on Friday.

Captain of the Sauces

The **Captain of the Sauces** competition is a free to enter fun contest for all competitors to enter. Bring your best recipe to compete for a trophy and bragging rights. Sauces will be judged by KCBS and SCA representatives and by community leaders.

Provide a quart of sauce for judging at turn-in time. Sauce turn-in will be on Saturday.

Entry fees* to compete in the York County BBQ Festival are listed in the table below. For your entry fee, you will receive a 20'X30' space with access to 20 Amp electrical service and central water. You must cook in all categories to be eligible for Grand Champion and Reserve Grand Champion.

Remember, you are not officially accepted in this contest until the entry fee is received.** Check must be received by 4/01/19 in order to qualify for Early Bird Discount. This is a rain or shine event.

^{*} Entry Fee must be received before your team will be accepted as a competitor. All teams will be notified via email when team entry form has been received. For additional information, contact Ken Jensen at kendjensen@gmail.com, or 732-513-8331.
